

Manage investments

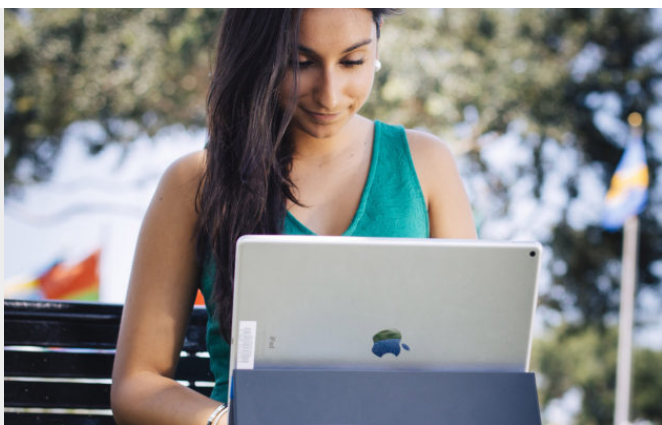
